## **Cycle against Suicide Mediterranean Cruise Raffle – Terms and Conditions**

1. **PROMOTION DESCRIPTION:** The Mediterranean Cruise Raffle ("Raffle") begins on 21<sup>st</sup> Nov 2018 and ends on 1st Jan 2019 at 12:00pm (the "Promotion Period").

The sponsor of this Raffle is Cycle against Suicide ("Sponsor"). By participating in the Raffle, each Entrant unconditionally accepts and agrees to comply with and abide by these Official Rules and the decisions of Sponsor, which shall be final and binding in all respects. Sponsor is responsible for the collection, submission or processing of Entries and the overall administration of the Raffle.
